**BUSINESS RESCUE PROCEEDINGS OF SAXENDRIFT MINE PROPRIETARY LIMITED**

1. As you are aware from the previous correspondence sent to affected persons of Saxendrift Mine Proprietary Limited ("Saxendrift/company"), this company was placed in business rescue, by means of a court order, on 18 May 2017 and Trevor Murgatroyd and Peter van den Steen were appointed as the joint business rescue practitioners.
2. On the basis that Saxendrift is in business rescue, please take note that –
  - 2.1 no equipment belonging to you or your company can be removed from the premises of the company and/or the mine without the consent of the business rescue practitioners;
  - 2.2 if you or your company are in possession of equipment belonging to the company and/or the mine, please send us a list of what is in your possession and the reasons for such possession, as soon as possible;
  - 2.3 any claims that you or your company have against the company as at the date of the commencement of business rescue –
    - 2.3.1. fall within the moratorium against claims against the company and cannot be enforced against the company;
    - 2.3.2. will be dealt with in terms of the business rescue plan that the business rescue practitioners will be preparing in due course;
    - 2.3.3. should be submitted to the business rescue practitioners in the form of the claim forms provided to you at the first meeting of creditors on 31 May 2017. A copy of the claim form is on the company's website (at the address below) and a copy is also available on request; and
    - 2.3.4. all claims submitted to the business rescue practitioners will be reviewed and only once communicated in writing as accepted, will be deemed to have been accepted by the business rescue practitioners as a valid claim;
  - 2.4 in terms of section 136(2)(a) of the Companies Act 71 of 2008, as amended, the company's obligations to make payment of any and all amounts, including interest and costs, in terms of any agreement or arrangement concluded between any party with the company is suspended, for the duration of the business rescue proceedings of the company, and until such time as you are otherwise advised in writing.


